### Online Motorsport Driver's License Applicant Declaration

1. I am not currently disqualified from receiving or holding a driving license under the Traffic Ordinance or any other enactment, and the court has not revoked my license under the Traffic Ordinance or disqualified me from receiving or holding such a license.\*
2. I am not currently disqualified from receiving or holding a sport driving license under the Motorsport driver's Law and its regulations or any other enactment, and the court has not revoked my motorsport driver's license or disqualified me from receiving or holding such a license.
3. My current motorsport driver's license has not been revoked or suspended by the Motorsport driver's Authority under section 20 of the Law or section 7 of the Medical Fitness Regulations.
4. I hereby declare that I have no outstanding fine which I undertook to pay under the Motorsport driver's Law.
5. I hereby undertake that in the event of a change in one or more of the situations specified in paragraphs 1-3 above, I shall immediately discontinue sport driving activity, report the change to the Motorsport driver's Authority within 7 days of its occurrence, and deposit the license with the Motorsport driver's Authority straightaway.
6. I hereby undertake to comply with the provisions of the Motorsport driver's Law and its regulations (including the Motorsport driver's (Mandatory Insurance) Regulations, 5770-2010), the Motorsport driver's Rules and the Motorsport driver's Authority's directives, as published from time to time.
7. I am well aware of the risks involved in competitive driving, and therefore undertake to act with the utmost responsibility and caution required in the circumstances, with an emphasis on the safety of the audience and the competitors.

8. The motorsport driver's license application has been filled out in accordance with all statutory requirements, including the provisions of the Motorsport driver's Law, 5766-2005, the Motorsport driver's Regulations (Motorsport driver's License), 5771-2010 and the Motorsport driver's Regulations (Medical Fitness Rules), 5771- 2010.
9. All the information and details which I have given in this declaration are complete, correct and true and unaltered.
10. **All the documents which I have attached to the online application form are true to the original and their details are correct, complete, accurate and unaltered.**
11. I undertake to update this declaration without delay should a material change occur regarding its contents.
12. **I undertake to keep the original documents in my possession for a period of 3 years from the date of signing this document.**
13. I am aware that if required to do so I shall hand over the original documents, immediately, to the Motorsport driver's Authority and to any party authorized to request them by law.

**I am aware that should the declaration in this document, including vis-à-vis the documents which I have attached, be incorrect, I shall be liable for statutory penalties.**
